ASSAY PROCEDURE SUMMARY

- 1. Prepare all reagents and standards as directed.
- 2. Add 300 μL of *Washing Buffer (1×)* per well to soak for about 30 seconds. Use immediately after aspirate.
- 3. Add 50 μL of diluted *Antibody* to each well except Blank, NSB and TA wells. Add 50 μL of *Assay Buffer (1×)* to NSB well.
 - 4. Incubate for 1.5 hours at 22-28 °C. Aspirate and wash 6 times.
- 5. Add 100 μL of serial diluted *Standard* to Standard wells. Add 100 μL of prepared samples to Sample wells. Add 100 μL of *Standard Diluent* or cell culture medium to B₀ well. Add 100 μL of *Assay Buffer (1×)* to NSB well. (The treatment refers to the Sample Preparation on Page 6).
 - 6. Add 50 µL of diluted *PGE2 Conjugate* to each well except Blank and TA wells.
 - 7. Incubate for 2 hours at 22-28°C. Aspirate and wash 6 times.
 - Add 100 μL of diluted *Streptavidin-HRP* to each well except Blank and TA wells. Incubate for 1 hour at 22-28°C. Aspirate and wash 6 times
 - 9. Add 1 µL of diluted *Streptavidin-HRP* to TA well.



10. Add 100 μL *Substrate Solution* to each well. Incubate for 5 - 30 minutes at 22-28°C. Protect from light.



11. Add 100 µL Stop Solution to each well.



12. Read at 450 nm within 30 minutes. Correction 570 or 630 nm.



DESCRIPTION

Prostaglandin E2 (PGE2), also known as dinoprostone, is a naturally occurring prostaglandin which is used as a medication. Prostaglandin E2 is in the oxytocics family of medications. It works by binding and activating the prostaglandin E2 receptor which results in the opening and softening of the cervix and dilation of blood vessels. It is a direct vasodilator, relaxing smooth muscles, and it inhibits the release of noradrenaline from sympathetic nerve terminals. PGE2 also plays a role in hippocampal synaptic plasticity and febrile responses. Furthermore, PGE2 also stimulates tumor cell proliferation and differentiation as well as tumor-associated neovascularization. PGE2 also suppresses T cell receptor signaling and may play a role in resolution of inflammation.

PRINCIPLE OF THE ASSAY

This assay employs a solid-phase competitive Enzyme-Linked Immunosorbent Assay (ELISA) technique. Rabbit anti-mouse IgG polyclonal antibody has been pre-coated onto a microplate. Monoclonal antibody specific for PGE2 is added into the wells, and is bound by the immobilized antibody following incubation. After washing, biotin-labeled PGE2 and purified PGE2/sample is added to compete for limited sites on the monoclonal antibody. After removal of any unbound substances, streptavidin-HRP is added for a second incubation. After washing, substrate solution reacts with HRP and color develops in proportion to the amount of PGE2 bound by the immobilized antibody. The color development is stopped by addition of acid and the optical density value is measured by microplate reader.

LIMITATIONS OF THE PROCEDURE

- ▶ FOR RESEARCH USE ONLY. NOT FOR USE IN DIAGNOSTIC PROCEDURES.
- > Do not use expired kit or reagents.
- > Do not use reagents from other lots or manufacturers. Do not prepare component by yourself.
- If concentration of assayed factor in samples is higher than the highest standard, dilute the serum/plasma samples with Assay Buffer, dilute the cell culture supernate samples with cell culture medium. Reanalyze these and multiply results by the appropriate dilution factor.
- Any variation in testing personnel, sample preparation, standard dilution, pipetting technique, washing techniques, incubation time, temperature, kit age and equipment can cause variation in results.
- This assay is designed to eliminate interference by factors present in biological samples. Until all factors have been tested in the ELISA immunoassay, the possibility of interference cannot be excluded.





MATERIALS PROVIDED (96 Test)

Unopened kit should be stored at 2 - 8°C.



- Rabbit anti-mouse IgG Microplate (1 plate): 96-well polystyrene microplate (12 strips of 8 wells) coated with a polyclonal antibody against mouse IgG.
- **PGE2 Antibody** (1 vial, 120 μL): 50× liquid.
- > PGE2 Standard (1 vial, 20 µL): Recombinant PGE2 in organic solvent; 100× liquid.
- PGE2 Conjugate (1 vial, 100 µL): Recombinant Biotin-conjugated PGE2 in organic solvent; 100× liquid.
- Streptavidin-HRP (1 vial, 120 µL): 100× liquid.
- > Assay Buffer (10×) (1 bottle, 10 mL): PBS with 0.5 % Tween-20 and 5 % BSA.
- Substrate (1 bottle, 11 mL): TMB (tetramethyl-benzidine).
- > Stop Solution (1 bottle, 11 mL): 0.18 M sulfuric acid.
- ➤ Washing Buffer (20×) (1 bottle, 50 mL): PBS with 1 % Tween-20.
- Plate Covers (6 strips).

STORAGE

Store kit reagents between 2 and 8°C. Immediately after use remaining reagents should be returned to cold storage (2 to 8°C). Expiry of the kit and reagents is stated on labels.

Expiration date of the kit components can only be guaranteed if the components are stored properly, and if, in case of repeated use of one component, this reagent is not contaminated by the first handling.

OTHER SUPPLIES REQUIRED

- Microplate reader capable of measuring absorbance at 450 nm, with correction wavelength set at 570 nm or 630 nm.
- > Pipettes and pipette tips.
- > 50 μ L to 300 μ L adjustable **multichannel micropipette** with disposable tips.





- > Multichannel micropipette reservoir.
- > Beakers, flasks, cylinders necessary for preparation of reagents.
- > Deionized or distilled water.
- > **Polypropylene** test tubes for dilution.

- In order to avoid microbial contamination or cross- contamination of reagents or specimens which may invalidate the test use disposable pipette tips and/or pipettes.
- > Use clean, dedicated reagent trays for dispensing the conjugate and substrate reagent.
- > Exposure to acid inactivates the HRP and antibody conjugate.
- ▶ Glass-distilled water or deionized water must be used for reagent preparation.
- Substrate solution must be warmed to room temperature(22-28°C) prior to use.
- Decontaminate and dispose specimens and all potentially contaminated materials as they could contain infectious agents. The preferred method of decontamination is autoclaving for a minimum of 1 hour at 121.5°C.
- Liquid wastes not containing acid and neutralized waste may be mixed with sodium hypochlorite in volumes such that the final mixture contains 1.0 % sodium hypochlorite. Allow 30 minutes for effective decontamination. Liquid waste containing acid must be neutralized prior to the addition of sodium hypochlorite.
- In some cases, an insoluble precipitate of stabilizing protein has been seen in the Standard Diluent. This precipitate does not interfere in any way with the performance of the test and can thus be ignored. Or remove precipitate by centrifuging at 6,000 × g for 5 minutes.

TECHNICAL HINTS

- > When mixing or reconstituting protein solutions, always avoid foaming.
- To avoid cross-contamination, change pipette tips between additions of each standard level, between sample additions, and between reagent additions. Also, use separate reservoirs for each reagent.
- > When using an automated plate washer, adding a 30 seconds soak period before washing step





and/or rotating the plate between wash steps may improve assay precision.

- > To ensure accurate results, proper adhesion of plate sealers during incubation steps is necessary.
- Substrate Solution should remain colorless until added to the plate. Keep Substrate Solution protected from light. Substrate Solution should change from colorless to gradations of blue.
- Stop Solution should be added to the plate in the same order as the Substrate Solution.
- The color developed in the wells will turn from blue to yellow upon addition of the Stop Solution. Wells that are green in color indicate that the Stop Solution has not mixed thoroughly with the Substrate Solution.
- > It is recommended that all samples and standards be assayed in duplicate.
- > Take care not to scratch the inner surface of the microwells.

SAMPLE COLLECTION AND STORAGE

Cell Culture Supernatants – Remove particulates by centrifugation at $300 \times g$ for 10 minutes and assay immediately or aliquot and store samples at ≤ -20 °C.

Serum – Use a serum separator tube (SST) and allow samples to clot for 30 minutes before centrifugation for 10 minutes at 1,000 × g. Remove serum and assay immediately or aliquot and store samples at \leq -20°C.

Plasma – Collect plasma using EDTA, citrate or heparin as anticoagulant. Centrifuge at $1,000 \times \text{g}$ within 30 minutes of collection. Assay immediately or aliquot and store samples at $\leq -20^{\circ}$ C.

Other biological samples might be suitable for use in the assay. Cell culture supernatants, serum and plasma were tested with this assay.

Note: Samples containing a visible precipitate must be clarified prior to use in the assay. Do not use grossly hemolyzed or lipemic specimens.

If samples are to be run within 24 hours, they may be stored at 2 to 8 $^{\circ}$ C. For longer storage, aliquot samples and store frozen at -20 $^{\circ}$ C to avoid loss of bioactive PGE2. Avoid repeated freeze-thaw cycles. To inhibit prostaglandin synthesis by COX-2, indomethacin should be added to serum and plasma collection tubes immediately following draw (to a final concentration of approximately 10 µg/ml).





SAMPLE PREPARATION

Normal serum and plasma samples require a 200-fold dilution. A suggested 200-fold dilution is 5 μ L sample + 995 μ L Assay Buffer (1×).

REAGENT PREPARATION

Bring all reagents and samples to room temperature(22-28°C) before use. If crystals form in the Buffer Concentrates, warm and gently stir them until completely dissolved.

Washing Buffer (1×)

Pour entire contents (50 mL) of the **Washing Buffer (20**×) into a clean 1000 mL graduated cylinder. Bring to final volume of 1000 mL with pure or deionized water. Mix gently to avoid foaming.

Transfer to a clean wash bottle and store at 2 to 25° C. Washing Buffer (1×) is stable for 30 days.

Assay Buffer (1×)

Pour the entire contents (10 mL) of the Assay Buffer (10×) into a clean 100 mL graduated cylinder. Bring to final volume of 100 mL with distilled water. Mix gently to avoid foaming. Store at 2 to 8°C. Assay Buffer (1×) is stable for 30 days.

PGE2 Antibody

Mix well prior to making dilutions.

Make a 1: 50 dilution of the concentrated PGE2 Antibody solution with Assay Buffer $(1\times)$ in a clean plastic tube as needed.

The diluted PGE2 Antibody should be used within 30 minutes after dilution.

PGE2 Conjugate

Mix well prior to making dilutions.

Make a 1: 100 dilution of the concentrated PGE2 Conjugate solution with Assay Buffer $(1\times)$ in a clean plastic tube as needed.

The diluted PGE2 Conjugate should be used within 30 minutes after dilution.

Streptavidin-HRP

Mix well prior to making dilutions.

Make a 1: 100 dilution of the concentrated **Streptavidin-HRP** solution with Assay Buffer $(1\times)$ in a clean plastic tube as needed.

The diluted Streptavidin-HRP should be used within 30 minutes after dilution.

Sample Dilution

If your samples have high PGE2 content, dilute serum/plasma samples with Assay Buffer $(1\times)$. For cell culture supernatants, dilute with cell culture medium without serum.

PGE2 Standard

The concentration of provided PGE2 Standard is 4,000 pg/mL. The PGE2 Standard contains an organic solvent. Pipette the Standard up and down several times to wet the pipet tip before transfer to insure that volumes are dispensed accurately.

Use polypropylene tubes.





For serum/plasma samples, mixing *concentrated PGE2 standard* (230 μ L) with 230 μ L of *Standard Diluent* creates the high standard (2,000 pg/mL). Pipette 230 μ L of *Standard Diluent* into each tube. Use the high standard to produce a 1:1 dilution series (scheme below). Mix each tube thoroughly before the next transfer.

For cell culture supernatants, mixing *concentrated PGE2 standard* (230 μ L) with 230 μ L of cell culture medium without serum creates the high standard (2,000 pg/mL). Pipette 230 μ L of cell culture medium without serum into each tube. Use the high standard to produce a 1:1 dilution series. Mix each tube thoroughly before the next transfer.




PLATE SETUP

Each plate or set of strips must contain a minimum of two Blanks, two non-specific binding wells (NSB), two maximum binding wells (B₀), and an eight point standard curve run in duplicate.

Note: Each assay must contain this minimum configuration in order to ensure accurate and reproducible results. Each sample should be assayed at two dilutions and each dilution should be assayed in duplicate. For statistical purposes, we recommend assaying samples in triplicate.

A suggested plate format and pipetting summary are shown below. The user may vary the location and type of wells present as necessary for each particular experiment.


Blank: background absorbance.


NSB (Non-Specific Binding): non-immunological binding of the conjugate to the well.

TA (Total Activity): total enzymatic activity of the conjugate.

 B_0 (Maximum Binding): maximum amount of the conjugate that the antibody can bind in the absence of free analyte.







ASSAY PROCEDURE

Bring all reagents and samples to room temperature(22-28°C) before use.

- 1. Prepare all reagents including microplate, samples, standards and working solution as described in the previous sections.
- 2. Remove excess microplate strips and return them to the foil pouch containing the desiccant pack, and reseal for further use.
- 3. Add 300 μL Washing Buffer (1×) per well, and allow it for about 30 seconds before aspiration. Soaking is highly recommended to obtain a good test performance. Empty wells and tap microwell strips on absorbent pad or paper towel to remove excess Washing Buffer (1×). Use the microwell strips immediately after washing. Do not allow wells to dry.
- Add 50 μL of diluted *Antibody* to each well except Blank, NSB and TA wells. Add 50 μl *Assay Buffer (1×)* to NSB well.
- 5. Cover with an adhesive strip. Incubate at room temperature (22 to 28°C) for 1.5 hours on a microplate shaker set at 300 rpm.
- 6. Aspirate each well and wash, repeating the process five times for a total six washes. Wash by filling each well with 300 μL *Washing Buffer (1×)*. Complete removal of liquid at each step is essential to good performance. After the last wash, remove any remaining Washing Buffer by aspirating or decanting. Invert the plate and blot it against clean paper towels.
- Add 100 μL of serial diluted *Standard* to Standard wells in duplicate. Add 100 μL of prepared samples to Sample wells. Add 100 μl of *Assay Buffer (1×)* (serum/plasma) or *cell culture medium* (cell culture supernatants) to B0 wells. Add 100 μL of *Assay Buffer (1×)* to NSB wells. (The dilution refers to the Sample Preparation on Page 6).
- Add 50 μL of diluted *PGE2 Conjugate* to each well except Blank and TA wells. Ensure reagent addition in step 7 and 8 is uninterrupted and completed within 15 minutes.
- 9. Cover with an adhesive strip. Incubate at room temperature (22 to 28°C) for 2 hours on a microplate shaker set at 300 rpm. Repeat aspiration/wash as in step 6.
- 10. Add 100 µL of diluted Streptavidin-HRP to each well except Blank and TA wells.
- 11. Seal the plate with a fresh adhesive film. Incubate at room temperature (22 to 28°C) for 1 hour



on a microplate shaker set at 300 rpm. Repeat aspiration/wash as in step 6.

- 12. Add 1 µL of diluted *Streptavidin-HRP* to TA well.
- 13.Add 100 μL of *Substrate Solution* to each well. Incubate for 5 30 minutes at room temperature(22-28°C). Protect from light.
- 14. Add 100 μL of *Stop Solution* to each well. The color will turn yellow. If the color in the well is green or if the color change does not appear uniform, gently tap the plate to ensure thorough mixing.
- 15. Measure the optical density value within 30 minutes by microplate reader set to 450 nm. If wavelength correction is available, set to 570 nm or 630 nm. If wavelength correction is not available, subtract readings at 570 nm or 630 nm from the readings at 450 nm. This subtraction will correct for optical imperfections in the plate. Reading directly at 450 nm without correction may generate higher concentration than true value.

CALCULATION OF RESULTS

Average the duplicate readings for each standards (including B_0) and sample, and subtract the average NSB optical density (O.D.).

% B/B_0 can be calculated by dividing the corrected O.D. for each standard or sample by the corrected B_0 O.D. and multiplying by 100.

Plot % B/B_0 for standards S1 - S8 versus PGE2 concentration using linear (y) and log (x) axes and draw the best-fit curve through the plotted points (e.g. 4-parameter logistic).

Calculate the concentration of PGE2 corresponding to the mean absorbance from the standard curve.

Note: Blank and TA values are not used in the standard curve calculations. Rather, they are used as diagnostic tools.


The finally concentration of top standard is 2,000 pg/mL. If samples have been diluted following the instruction, the final dilution factor is 200. If sample have been diluted by other means, the concentration read from the standard curve must be multiplied by the appropriate dilution factor.

TYPICAL DATA

A standard curve must be run within each assay. This standard curve is provided for demonstration only.

SENSITIVITY

The minimum detectable dose (MDD) of PGE2 is typically less than 1.08 pg/mL. The MDD was determined by subtracting two standard deviations to the mean optical density value of ten zero standard replicates and calculating the corresponding concentration.

PRECISION

Intra-assay Precision (Precision within an assay)

Three serum-based and buffer-based samples of known concentration were tested twenty times on one plate to assess intra-assay precision.

Inter-assay Precision (Precision between assays)

Three serum-based and buffer-based samples of known concentration were tested in six separate assays to assess inter-assay precision.



RECOVERY

The spike recovery was evaluated by spiking 3 levels of PGE2 into five health serum samples. The un-spiked serum was used as blank in these experiments.

The recovery ranged from 92 % to 102 % with an overall mean recovery of 99 %.





LINEARITY

To assess the linearity of the assay, five samples were spiked with high concentration of PGE2 in serum and diluted with Standard Diluent to produce samples with values within the dynamic range of the assay.

CALIBRATION

This immunoassay is calibrated against a highly purified recombinant PGE2 produced at Multi Sciences.

SAMPLE VALUES

Serum/Plasma - Thirty samples from apparently healthy volunteers/mice/rats were evaluated for the presence of PGE2 in this assay.
